## Scope of NCOC collaboration with RSPs



Pakistan's first, organised community-led response in rural areas to the COVID-19 emergency



This unique public-private partnership between the GOP and community

Local Support Organisations (LSOs) created by RSPs, is strengthening citizen-state links.

LSOs are union council-level community institutions



In **1500** union councils of 66 districts seven RSPs are entering into agreements with district administrations as a public service, linking LSOs to government to battle COVID-19;



**1,500** LSOs in 66 districts in all provinces, AJK, GB and NMDs will work with government through trained community activists (women and men) to create awareness about COVID-19, preventive measures, assist in contact tracing and reporting of suspicious cases (TTQ), after being trained by district authorities;



About **20 million** people will benefit from this collaboration.

## Case studies on community leaders' work

### Case 1:

## Muhammad Yousuf (President LSO) & Rehmatullah (Manager LSO) of LSO Sangat, UC Sikhani Wala, Dist. Rajanpur, Punjab

### **Training**

Muhammad Yousuf and Rehmatullah attended the training conducted on combating COVID-19 by the Govt. Health Department, on 2nd June 2020.

### **Activities of Community Leaders**

- Awareness sessions on COVID-19 an village level:
- Announcements in local mosques for community awareness, distancing;
- Training for community members on making face masks at home;
- Spraying antiseptic-mixture in mosques and public places;

### **Community response**

People listen to LSO leaders and take their advices on precautionary measures against COVID-19 seriously and have started following measures like social distancing, avoiding crowded places, not visiting relatives, etc.

**Challenges:** Significant transportation issues are being faced and they need sanitizer as they cannot afford to buy this.





### Case 2:

## Ms. Shameem (Community Resource Person-CRP) UC/LSO Odero Lal Station, District Matiari, Sindh

### **Training**

Shamim received training on community awareness and COVID-19 from NRSP.

### **Activities**

Delivered awareness sessions on health/hygiene and COVID-19 preventive measures, and also distributed soap among poorest households.

### **Community response**

Very positive and attended awareness sessions on COVID-19 eagerly.

### **Challenges**

Due to closure of transportation, it is very tough for her to commute by foot to deliver awareness session in adjacent villages.

## Lessons, Challenges & Recommendations

- There is a general lack of awareness about COVID-19 and preventive measures in rural areas unlike the common perception that everyone is aware;
- People's response is overall positive. Communities are eager to get information on disease and gain knowledge about preventive measures;
- Provincial & district authorities have started realising the importance of social capital ie community institutions fostered by RSPs, to put out awareness messages. They have shown interest to work through community institutions to deliver other, essential services eg EPI, polio campaigns, family planning, etc.;
- Initial results from the collaboration are more positive where the provincial governments are strongly leading the initiative;
- RSPs are supporting NCOC collaboration through other, funded programmes. Scale-up, if required, can only be done through providing RSPs with resources;
- There is increased violence at household level due to male unemployment creating economic stress;
- Protection of community activists and RSP staff is extremely important ie PPEs. NCOC is requested to facilitate this. RSPN is collecting PPE demand from RSPs.
- Many district administrations have no training material or training expertise. RSPs doing this at their own cost in most districts;
- Health Department needs to provide clear guidelines to communities and ensure cooperation in contact tracing and reporting of suspicious cases. This requires testing and follow up. Testing facilities non existent in rural areas. Testing facility in Balochistan only in Quetta.

## **Next Steps**

- 17 district MOUs remain to be signed (5 Balochistan, 4 GB, 5 KP, 2 Punjab, 1 Sindh)
- RSPs are increasingly coordinating activities funded by donors and others in these UCs for greater impact
- Communication strategy submitted by RSPN to NCOC needs feedback
- Current 1500 UCs in 66 districts are being done at RSP cost. Any scale-up first has to address these challenges and provide resources to RSPs, following which RSPs can consider scale-up.
