

Report on Conflict Resolution by LSO PARAWZ

The LSO PARWAZ was formed on 20th September, 2013 at Union Council Mandani Tehsil Tangi, District Charsadda. The Executive body and general body of LSO PARWAZ include both male and female community members. Registration of LSO with Social Welfare Department KPK under Society act is in process and the entire necessary documents has been submitted.

There was a prolong Land dispute between two parties from seventeen (17) years at village Sabandi Union Council Mandani. One person was also shot dead of one party due to this land conflict and the other party had also entered the case in Court. Local stakeholders/elders did efforts many times to resolve the issue but in vain.

LSO PARWAZ successfully resolved this seventeen year's old dispute among the two parties. The LSO executive body members nominated four representatives, Mr. Shah Jee Akbar President of LSO PARWAZ and Sami Ullah (Local Stakeholder) on behalf of one party and SHO Police Station

The LSO Executive body next day for proper announcement of agreed decision. Except LSO Executive body members, the parties individuals, DPO Mr. Shafi Ullah Khan, Assistant Commissioner Tangi, Tehsildar Tangi and SRSP Field Unit Tangi HID Team representative also participated in the event. This was one of the major task of LSO, which they have achieved in very early stage.
