**MINUTES OF THE MEETING HELD BY THE PROGRAM MANGER ACCELERATED ACTION PLAN (AAP) ON 15<sup>TH</sup> DECEMBER, 2017 WITH RSPN SPECIALIST FOR DIVISION OF RURAL UNION COUNCILS OF PINS DISTRICT BETWEEN ER-3 AND AAP's CONCERNED DEPARTMENT.**

After the recitation from the Holy Quran, the Program Manager welcomed all the participants and briefed the participants the purpose of the above said meeting to divide Union Councils between the ER-3 project of PINS funded by European Union (to be implemented by RSPN) and Accelerated Action Plan (AAP).

**Decisions:**

1. RSPN will prepare and share the manual of the project by the end of January 2018.
2. RSPN will be in the field for the implementation of the project from 1<sup>st</sup> March, 2018.
3. Out of 29 Districts in Sindh Province, RSPN will cover 10 Districts namely, Jamshoro, Matiari, Tando Muhammad Khan, Thatta, Sujawal, Dadu, Larkana, Tando Allahyar, Kamaber, Skhikarpur.
4. The selection of the 10 Districts is based on (level of Malnutrition) status of Malnutrition, geographic access and ODF practice.
5. It has been identified that no duplication of nutrition sensitive interventions will take place between Accelerated Action Plan (AAP) & Rural Support Programmes Network (RSPN) Project. PINS project would support AAP intervention.
6. In each of ten district, RSPN will cover 50% of the rural union councils for the nutrition sensitive interventions. Below given chart provides the details of rural unions councils to be covered for achieving the set target by the RSPN.

8. Social awareness package to be re-designed for Nutrition related activities by RSPN.
9. RSPN will regularly report to Task Force Secretariat.
10. RSPN will participate in monthly meeting of Task Force Secretariat and share the progress.
11. The remaining 50% of the rural union councils will be covered under the AAP.
12. RSPN will also provide guidance and community support to the people in those rural union councils.
