Visit to Islamabad

Under "Programme for Improved Nutrition in Sindh (PINS)" Project

March 22nd 2018: I travelled from Karachi to Islamabad by air departed at 2:15 pm and reached Islamabad at 6:00 pm.

The COO RSPN, Mr. Khaleel Ahmed Tetlay welcomed the participants and briefed them about the objective of the consultative meeting:

- I. **Project introduction**: EU funded RSPN Project "Programme for Improved Nutrition in Sindh (PINS) and RSPN three tier (CO, VO & LSO) approach of social mobilization
- II. Consultation for WASH Component of PIM (Programme Implementation Manual)

Then Mr. Muhmmad Bashir Anjum gave power point presentation on EU Funded Project of RSPN i,e. Programme for Improved Nutrition in Sindh (PINS). The RSPs' three tier approach was discussed in detail. This detailed presentation was followed by presentation on PIM WASH (outline & narrative part) by Mr. Kayani.

During the discussion following major points were discussed:

- There is strong need to inculcate Theory of Change (ToC) to create social norms for sustaining behaviors to address the post ODF challenges, Mr. Kamran Naeem, WASH Specialist volunteered himself to facilitate the session under ToT (at Karachi); However, Mr. Bashir Anjum has agreed to spare a full day for this, however Mr. KN will share the relevant material with RSPN in this regard.
- PATS approach may be re-enforced alongwith CATS rather than CLTS focused only.



- 3. Private sector (particularly RB & Unilever) may also be consulted for "social marketing" as funds under Project are not allocated for marketing/campaigning of social norms around WASH.
- 4. Coordination with PCWR Islamabad (at federal level) and at Sindh level (Karachi) needs to be strengthened.
- 5. Unicef have provided water testing kits/equipment to AKU for National Nutritional Survey 2017/18 and has suggested to use their results and even equipment for 10 project districts. Unicef will further coordinate with AKU.
- 6. Mr. Kamran Naeem proposed that there may be forum at national level to share the learnings (PINS Project) at federal level and quarterly meeting may be held at Islamabad with sector (WASH) partners. He can facilitate developing linkages with MoCC to own and take lead on it.
- 7. National Environment Quality Standards (Enqs) may be followed for water quality assessment, monitoring and social development techniques for water in collaboration with PCRWR.
