# **Overview**

Government of Sindh (GoS) through its Planning and Development Department (PDD) is implementing a six-year multi-sectoral Sindh Accelerated Action Plan(AAP) for Reduction of Stunting and Malnutrition with the objective of reducing stunting rate from the existing 48 percent to 40 percent by 2021. The European Union (EU), under the EU Commission Action Plan on Nutrition 2014, is supporting GoS in addressing the issue of malnutrition. Therefore, EU Brussels Office has approved the four-year Programme for Improved Nutrition in Sindh (PINS) to be implemented in ten districts of Sindh starting from February 15, 2018 and ending in July 14, 2021.

RSPN is leading the PINS Nutrition sensitive component (Expected Result-3) with four partners: Action Against Hunger (ACF), National Rural Support Programme (NRSP), Sindh Rural Support Organisation (SRSO) and Thardeep Rural Development Programme (TRDP). This component includes nutrition sensitive interventions i.e. Water, Sanitation and Hygiene (WASH) and Agriculture & Food Security (AFS).

Rural Support Programmes Network (RSPN) in connection with WASH component coordinated with Accelerated Action Plan (AAP), Government of Sindh for notification for nominations from the district the ODF certification committees under the chair of deputy commissioner of respective district aimed at certify the villages as Open Defecation Free status. The notified committee headed by Local Government Department and have representation from Public Health and Engineering Department, Department of Health, Education and Social Welfare Department. In each district, two days training of District ODF certification Committees will be organized in order to orient the district ODF certification committee members on their role and responsibilities for certification of RSPs' intervened villages as open defecation free.

The district administration deputy commissioners, additional deputy commissioners and assistant commissioners of respective district and taluks participated in the workshops enthusiastically and directed the departmental nominees for taking active part in the workshop and get



oriented on their important role for ODF certification of villages.

Beside, district administration other WASH sector stakeholders also participated in the training workshops.

Respective RSPs Programme Managers and regional officials attended the events and provided introductory remarks on this forum by discussing the RSPs' approach and interventions in the district. Nazar Joyo, ArfatMajeed, Ali Muhammad Kallar, Hamid Magsi, Asad and Jamal Mustafa Shoro joined during these workshops.

#### Introduction

The workshop were started with recitation of verses from the Holy Quran and Participants were provided an opportunity to introduce themselves and their department. The participants were briefed about the programme specifically and shared the objectives of these series of workshops.

# Training Objectives and Individual Pre-Test

- To orient the members about their role and responsibilities of ODF certification committees, process for initial and sustainability certification and indicators to be used for certification.
- These training will also focus on how to provide support to VOs for ODF certification of their village.

# **Individual Pre-Test (Training Evaluation)**

The facilitator distributed a format to pre-test the knowledge, skills and aptitudes of the participants and guided them to respond on the given template to the best of their abilities.

The purpose of the pre-test was to analyse the conceptual undersanding of the participants regarding "District ODF Certification Committee and Its prime responsibility for OD free villages", so that the facilitator formulate a customized strategy for session delivery in better and appreciative manner. The template was English language and easily understandable for all the participants. pre training evaluation facilitated by RSPs staff aimed at incorporating into the narrative report.



However, it was really a challenging exercise to get input from Govt. officials as a part of pre training evaluation and took momentous efforts to mobilize them and get response as it required. Although, this template was introduced and briefed to the participants and followed by assistance by staff.

The participants were provided the relevant material for their in-depth learning on the conceptual understanding WASH terminologies, ODF certification tools, these included,

# **Training Methodologies**

The facilitator used a strategic and dynamic approach to deliver the session as the audience were distinctive in nature comparative to other development sectors. Trainee group consists of key officials of various departments; hence delivered session via multimedia approach, encourage discussion and brainstorming, experience sharing and audio - visual aids for clarity on CLTS triggering etc.

# **Training Workshop Proceeding**

#### Day One:

The workshop(s) begin with registration of the Participants and recitation of verses from Holy Quran followed by the Welcome Note by the RSPs' representative. After rapport building; Introduction session initiated through Ice breaking and participants were encouraged to express their expectations and concerns about these workshops. Trainee group keenly discussed the bees in their(s) bonnet and set the Norms for smooth proceeding of workshop(s), followed by the objectives and relevancy with Government officials

#### Session 1: Brief Session on Social Mobilization Approach and SUCCESS Intervention:

This session mainly conducted by RSPs PM / RM to brief audience about the social mobilization approach and community institutions raised / federated under SUCCESS programme. The emphasis was given to interventions such as MHIs, IGGs, CIF and others by focusing on PINS programme interventions as well. During the session the importance and contribution of Government Line departments under the umbrella of Accelerated Action Plan, Government of Sindh in implementation of Programme for Improved Nutrition in Sindh also highlighted.

#### Session 2: Introduction to WASH Interventions and its linkages with Nutrition

The participants have been given an overview of PINS Programme, its interventions and district focus achievement against targets, Conceptual framework for analysing causes of malnutrition and a brief overview to PINS – ER3 and its Interventions with specific focus on programme district with the help of District Nutrition Profile and Programme achievement under PINS ER3.

Presentation of RSP District ODF Plan (Taluka, VOs with Settlements, HHs, population their status as ODF declared and month-wise/ verification for all designated areas / VOs.

At the end of presentation, Kamal Kar's video on CLTS Triggering is also shown to participants for further clarity on community led total sanitation approach leads to open defecation free villages and construction of latrines on self-help basis.

#### Session 4: Process for ODF Declaration, Verification, Certification and Celebrations

The participants were oriented on the process of ODF Declaration, Verification, Certification, Celebration and Post Sustainability. The session started with brief overview of following;

Presentation of RSP District ODF Plan (Taluka, VOs with Settlements, HHs, population their status as ODF declared and month-wise/ verification for all designated areas / VOs. The session also covered the ODF criteria first level and secondary level along with celebration principles with help of indicators and methodology.

#### Day Two:

Second day of the workshop(s) started with recitation of Holy Quran and recap of the concepts and topics covered on previous day. After these pre-requisites, the workshop(s) proceeds as per agenda.

#### Session 1: District ODF committee field plan & field arrangements

The facilitator with assistance of RSPs manager / DPOs discussed the tentative plan, which further will be discussed with district administration for further approval and go head to committee members to visit the villages to check ODF as per criteria oriented. The RSPs are subject to provide logistical facility to committee and also provide the list of VOs / villages to chair of committee.

#### Session 2: Introduction to ODF verification check list

The participants have been oriented on the process and familiarized with ODF verification check list. Moreover scenario for role play is for Village ODF declaration, verification and certification process using checklist.

The participants were provided the checklists and guidelines to use the tools for certification of OD free status of villages. The methodology was interactive and encouraged the groups to ask the questions for more clarity.

#### **Session 3: Operation and Maintenance of WASH structures**


The participants have been oriented on operation and maintenance of WASH structures:

 Assistant Commissioner KN Shah and Additional Commissioner - I Dadu also attended the training and express his views and asked one day refreshed for absent participants before going into the field for ODF certification,

#### **Conclusion remarks**

Deputy Commissioner(s) / ADCs mainly provided the closing remarks and discussed the

significance of the programme for improved nutrition in Sind and briefed the participants about their departments' integration in the DCCN forum. Further stressed the participants to understand the concepts, framework, indicators / criteria and ODF process and their role to certify declared village as ODF status. Further they thanked RSPs for their interventions related to WASH and efforts to certify the villages as OD Free status and also directed the committee members that the RSPs is doing the job






#### SUBJECT: REQUEST FOR NOTIFICATION OF DISTRICT OPEN DEFECATION FREE (ODF) COMMITTEES

Accelerated Action Plan for Reduction of Stunting and Malnutrition AAP is Government of Sindh's an overarching program for reducing stunting and malnutrition among children under five years of age. There are two important components of AAP including Sinch Enhancing Response to Reduce Stunting Project (SERRSP) supported by World Bank; and PINS (Program for Improved Nutrition in Sindh) assisted by European Union.

The Local Government (WASH) Sector is one of the most important sectors working along the both projects, which aims at to make villages Open Defecation Free (ODF).
